Sri Lanka ". (1A) Every person who immediately prior to the 22nd day of May, 1972, was a citizen of Ceylon shall, on and after that date, be entitled to be, and to be called, a citizen of Sri Lanka. (2) A person shall be or become entitled to the status of a citizen of Sri Lanka in one of the following ways only :—

(5) Every person who immediately prior to the commencement of the Constitution was a citizen of Sri Lanka, whether by descent or by virtue of registration in accordance with any law relating to citizenship, shall be entitled to the status and to the rights of a

citizen of Sri Lanka as provided in the preceding provisions of this Article.

Finally, it was the J.R Jayawardene government that came into power in the 1970s that revised the Citizenship Act, adding in a Special Provisions in the form of the Grant of Citizenship to Stateless Persons of Indian Origin, accepting all remaining Indian Tamils as citizens of Sri Lanka, equipping them with a nationality and a vote.
